PLANNING & INFRASTRUCTURE PORTFOLIO HOLDER DECISION: JANUARY 2018

WORK PROGRAMME FOR THE DESIGN AND IMPLEMENTATION OF HABITAT MITIGATION PROJECTS USING DEVELOPERS' CONTRIBUTIONS AND COMMUNITY INFRASTRUCTURE LEVY FUNDING

1 INTRODUCTION

- 1.1 New Forest District Council, through its planning development control powers, collects contributions (through Section 106 agreements and the Community Infrastructure Levy (CIL)) to mitigate the recreational impacts of new developments on the European nature designated conservation sites.
- 1.2 This report seeks to approve a programme of projects and expenditure for from January 2018 to March 2019 to implement the Council's adopted Mitigation Strategy for European Sites SPD and adopted Local Plan policies.

2 POLICY FRAMEWORK

- 2.1 Policy DM3 of the adopted Local Plan Part 2: Sites and Development Management Development Plan Document (DPD) sets out the Council's approach towards habitat mitigation. The four elements of the strategy can be summarised as:
 - Provision of new areas of publicly accessible natural green space.
 - Enhancement of existing green space and footpaths/rights of way.
 - Access management measures include the provision of additional rangers for the New Forest SPA and Solent Coastal European sites.
 - Monitoring the gathering of further information, including about the condition of European sites' habitats and species and visitor patterns, and to gain a better understanding of the effects of visitors and other factors influencing the condition of the protected sites; and the monitoring of progress in implementing the mitigation strategy.
- 2.2 In June 2014 the Council adopted its Mitigation Strategy for European Sites Supplementary Planning Document (SPD). This strategy lists specific projects and indicative timescales for the implementation of the strategy in accordance with policy DM3.

3 PROJECT PROPOSALS

3.1 Appendix 1 of this report details the programme of works that are intended to be implemented within the financial year 2018/19.

4 PROJECTS IMPLEMENTED 2017/17

- 4.1 Since the adoption of the strategy the following projects have been implemented:
 - Sandlehealth Recreational Walking Route

- North Milton Estate recreational mitigation land
- Merryfield/Heatherstone Grange recreational mitigation land
- King George Recreation Group Dog Exercise Area
- Lymington Recreational walks (Yaldhurst and Pennington)

5 MONITORING

- 5.1 In addition to the work of the People and Wildlife Ranger, in 2016/17 the Council purchased three visitor counters. Since their purchase, the counters have been displayed at the following locations (each for a 2 month period):
 - Merryfield / Heatherstone Grange
 - King George Recreation Ground
 - Lymington (Yaldhurst and Pennington)
 - North Milton
 - Buttsash Woodlands
 - Great Woar Copse / Ballard Lake, New Milton
- 5.2 Once a habitat mitigation project has been implemented the visitor counters will return to the same location during the same period of the year in order to record any differences in usage. It is hoped to show an increase in activity following implementation of the mitigation projects.

6 SOLENT RECREATION MITIGATION PARTNERSHIP

- 6.1 Since 2015, this Council has provided contributions to the Solent Recreation Mitigation Partnership (SRMP) in accordance with the Interim Mitigation Strategy. Since this time, contributions have ranged from £171 to £181 per dwelling (as the contributions have been index linked). In December 2017, PUSH endorsed a Definitive Mitigation Strategy which significantly increases the contributions to around £564 per dwelling depending on the size of the dwelling).
- 6.2 The actual contribution paid is based on a sliding scale and depends on the number of bedrooms provided as part of a development. The contributions will only be sought from those within 5.6km of the Solent SPA area.
- 6.3 The Council has continued to work with the SRMP and will continue to provide contributions towards the strategy. The new definitive strategy will provide the following:
 - A team of 5-7 coastal rangers to advise people on how to avoid bird disturbance, liaise with landowners, host school visits, etc;
 - Communications, marketing and education initiatives and an officer to implement them;
 - Initiatives to encourage responsible dog walking and an officer to implement them;
 - Preparation of codes of conduct for a variety of coastal activities;
 - Site-specific projects to better manage visitors and provide secure habitats for the priority bird species;
 - Providing new/enhanced greenspaces as an alternative to visiting the coast;
 - A partnership manager to coordinate and manage all the above.

7 FINANCIAL IMPLICATIONS

7.1 Habitat Mitigation Developer Contributions are collected for the sole purpose of implementing access management and monitoring schemes in accordance with policy DM3 and can only be spent on this purpose. In accordance with the Council's Regulation 123 list, money collected via CIL is spent on habitat mitigation projects as a priority.

8 CONSULTATION INPUT

8.1 The projects in the programme of works are all contained in the adopted Mitigation Strategy SPD. The SPD was subject to statutory consultation and adopted by Cabinet recommendation on 4 June 2014.

9 ENVIRONMENTAL IMPLICATIONS

9.1 Delivery of this programme of works will enable residential development to proceed in a way that will safeguard the protection of the European nature designated conservation sites. Implementation of this Mitigation Strategy is necessary to comply with the requirements of the Habitat Regulations.

10 CRIME AND DISORDER IMPLICATIONS

10.1 No programme-specific implications.

11 EQUALITY AND DIVERSITY IMPLICATIONS

11.1 A good design and feasibility process will help ensure that schemes respond to the needs of the whole community.

12 ANY ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

12.1 Suitable mitigation must be in place prior the occupation of development to be in accordance with the Habitat Regulations. If the programme of works is not approved and the projects are not implemented it could result in a breach of responsibilities under the Conservation of Habitats and Species Regulations 2010. Further, Natural England may raise objection to further residential development in the district until suitable mitigation is delivered

13 RECOMMENDATIONS

- 13.1 That the programme of works set out in Appendix 1 is approved to be implemented.
- 13.2 Authorises the Service Manager (Policy and Strategy), in consultation with the Portfolio Holder for Planning and Transportation, to make any amendments to the programme of works during the course of the programme should schemes no longer become achievable/alternative projects are identified that are deemed more suitable.

Programme of projects and expenditure: January 2018 - March 2019

This document sets out the programme of works and expenditure from January 2018 to March 2019 to implement projects and actions which are set out in the Mitigation Strategy for European Sites.

The agreed strategy has four main elements. These are:

- 1. Provision of new areas of publicly accessible natural green space.
- 2. Enhancement of existing green space and footpaths/rights of way.
- 3. Access management measures include the provision of additional rangers for the New Forest SPA and Solent Coastal European sites.
- 4. Monitoring the gathering of further information, including about the condition of European sites' habitats and species and visitor patterns, and to gain a better understanding of the effects of visitors and other factors influencing the condition of the protected sites; and the monitoring of progress in implementing the mitigation strategy.
