1. CHRISTMAS GLASS COLLECTIONS

- 1.1 The Portfolio Holder for the Environment proposes to revise the glass collection arrangements for Christmas 2018 and New Year 2019 in order to accommodate Public Holidays on 25 and 26 December 2018 and 1 January 2019. The proposed glass collection arrangements are detailed as follows:

- 1.3 The revised glass collection arrangements for Christmas 2018/19 have been agreed with Trade Union representatives and staff. There is an additional holiday for New Forest District Council staff on Monday 24 December 2018, but the Council's glass collectors have agreed to work on that day and will receive a day off in lieu at a later time.

2. PURPOSE

- 2.1 The proposed revised glass collection arrangements will inconvenience some New Forest residents but disruption to services at Christmas time is inevitable. These revised arrangements minimise disruption and allow the refuse collection service to get back to normal as quickly as possible.
- 2.2 for those households signed up to the text messaging service the revised collected dates will be sent out over the Christmas period

3. ALTERNATIVES CONSIDERED

- 3.1 The alternative options considered would prolong the disruption to residents. Furthermore, there are limitations over the Christmas period for the availability of the disposal sites due to planning restrictions.
